

ANODIZING LIMITED WARRANTY – 2 years

Manko Window Systems, Inc. ("Manko") warrants for a period two (2) years from the date of manufacture that all exposed anodized aluminum furnished by Manko and specified to be processed to Aluminum Association Standards (AAM12C22A31) shall conform to the following provided it is installed in and exposed to normal atmospheric conditions: Said aluminum will not develop excessive non-uniformity of color, and will not crack, peel, pit, or corrode, within the following limits and as defined per AAMA 611-14 (Voluntary Specification for Anodized Architectural Aluminum):

- "Excessive non-uniformity" means non-uniform fading during the period of this warranty as defined by AAMA 611-14 paragraph 8.7.2.
- "Will not pit or corrode" means that there shall be no pitting or other type of corrosion discernible by the naked eye from a distance of 10 feet resulting from the natural elements in the atmosphere as defined by AAMA 611-14 paragraph 8.6.2.

This warranty applies only if such anodized material is installed in strict accordance with Manko's recommended practices and installation instructions and maintained in accordance with American Architectural Manufacturers Association (AAMA) Publication Number 609.1 "Voluntary Guide Specification for Cleaning and Maintenance of Architectural Anodized Aluminum". Annual cleaning and maintenance must be documented, and proof thereof presented to Manko upon request.

This warranty will not extend or cover:

- 1. Damage to the finish occasioned by moisture or other contamination detrimental to the finish because of improper storage of the finished metal prior to installation.
- 2. Water damage due to condensation caused by improper repackaging of the finished metal prior to installation.
- 3. Damage to the finish caused by handling, fabrication, shipping and/or installation, or by use of the metal with any parts, gaskets, glazing materials, components, sealants, or dissimilar metals of other manufacturers used with Manko products.
- 4. Damage to finish caused by exposure to caustic or acidic materials.
- 5. Any particular application or selection of the metal for any particular project or design.
- 6. Any application of the anodized finish on any metal such as hardware.
- 7. Where failure is associated with exposure of the coating to the direct influence of zones of saltwater or other hazardous microclimate conditions. Unless, prior to application, Manko has consented in writing to warrant the coating as applied in the specific location.
- 8. Damage to the finish caused by post forming operations.

Limit on Remedies in the Event of Failure: In the event that any such anodized material fails to perform as warranted, Manko's sole responsibility and Purchaser's Sole and Exclusive Remedy under any warranty, contract, negligence or other claim of liability shall be limited to: at Manko's option, (1) repair, (2) a refund of Manko's original selling price or, (3) to furnish the purchaser with another product without charge, F.O.B. the shipping point nearest the product's installation. MANKO MAKES NO OTHER EXPRESS OR IMPLIED REPRESENTATION OR WARRANTY OF ANY KIND REGARDING THE PRODUCTS, WHETHER AS TO MERCHANTABILITY, FITNESS FOR A PARTICULAR PURPOSE OR USE, OR ANY OTHER MATTER.

Other Provisions: The provisions of Manko's Standard Limited Warranty and Remedy found on the last page in this document and at www.mankowindowsystems.com apply to, and are incorporated into, this Anodizing Limited Warranty.
